

Public Safety Emergency: State Employee Notification Process

Definition – “Public Safety Emergency”

- A Public Safety Emergency refers to ***all formal declarations which may limit a state employee’s obligation to travel to and from work*** for a specific period of time, during severe/winter weather, or during other incidents.

Purpose

- Notify all state employees when a Public Safety Emergency is declared
- Ensure non-essential employees are notified and do not report to work
- Ensure essential employees are notified of the incident and are aware of their obligation to travel to and from work

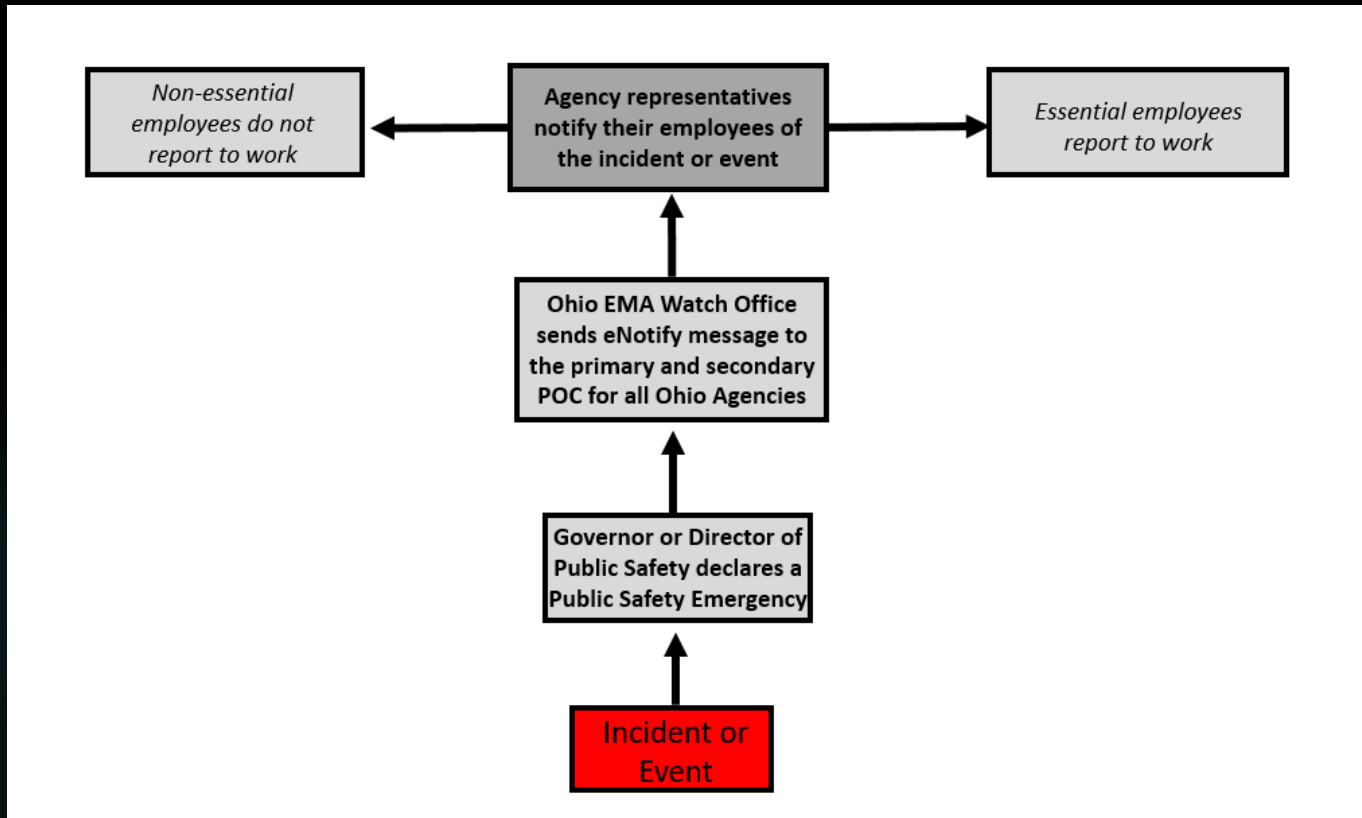


Concept of Operations

PSEN

- As conditions worsen to the extent that a serious threat to health and safety exists, consideration of a **Public Safety Emergency Declaration will be made by the Governor and his/her designee**
- The decision for the declaration will be **based off input from the State Highway Patrol, Ohio EMA, and other subject matter experts**
- Upon the declaration of a Public Safety Emergency, the **Ohio EMA Watch Office will initiate the notification of all state agencies, boards, and commissions** in accordance with Ohio DAS Directive HR-D-11
- Notification will be made **by way of voice, text alerts, and email;** and will include the following information:
 - County(s) involved
 - Time the declaration was issued
 - Time the declaration expires (if available)





- Once an incident occurs, information flows from the Governor/Designee to Ohio EMA to all other state agencies
- These agencies then notify their non-essential employees that they should not report to work

The Ohio Department of Public Safety's "e-Notify" system was developed to communicate information to a large group of people, such as in a weather emergency or security threat or for an important bulletin. The system provides an easy means to store contact information and automate the communication process at the touch of a button.

- No response will be required from you
- The test is a means to ensure all state agencies, commissions, and boards receive any future alerts

Essential Employees

PSEN

- Certain employees are expected to work during a Public Safety Emergency as they perform duties essential to continued Ohio DPS operations
- These employees are required to work as directed by their supervisors during emergencies
- Another presentation will follow, walking you through the process of officially designating an employee as essential/non-essential

EMPLOYEES EXPECTED TO WORK DURING A PUBLIC SAFETY EMERGENCY SHOULD SHOW A LAW ENFORCEMENT OFFICER ANY ISSUED PROOF OF EMPLOYEE DESIGNATION AND THEIR ISSUED DPS EMPLOYEE IDENTIFICATION *UPON REQUEST!!*
