



Certificate Screen Flow





GIVING OF FALSE INFORMATION OR OBTAINING A REMEDIAL COURSE CERTIFICATE IN AN UNLAWFUL MANNER

Any person giving false information, including using another individual's social security number, birth certificate, or other material or document information to obtain a remedial course certificate, or who lends or borrows any of these documents and displays or represents these documents issued to another person as their own, or who gives or receives a remedial certificate without fulfilling the requirements of OAC 4501-21 is subject to criminal penalties which may include a fine and/or imprisonment.
