

South Euclid Police Department Sobriety Checkpoint

On Friday, September 8, South Euclid Police Dept. conducted a sobriety checkpoint from 11:30 pm to 2:30 am. The results of this checkpoint are as follows:

OVI Arrests	2
Misc. Citations Issued	4
No Driver License on Person	6
Driving Under Suspension Citations	14
Safety Belt Violations	28
Total Citations Issued	22

There were 617 vehicles through the checkpoint area and officers checked 169 of these vehicles. The average time that each vehicle was stopped was approximately 37 seconds. Thirty of these vehicles were sent to the diversion area for various reasons, including not having a driver license with them, not wearing a safety belt, and suspicion of driving under the influence of alcohol.

Low-Manpower Sobriety Checkpoint Activity

On Sunday, September 24, the Wilmington Post of the Ohio State Highway Patrol and the Cincinnati Police Dept. conducted a low-manpower sobriety checkpoint from 11:30 pm to 3:15 am. The results of this low-manpower checkpoint are as follows:



There were 645 vehicles through the checkpoint area and officers checked all vehicles. The average time that each vehicle was stopped was approximately 23 seconds. Twenty-nine of these vehicles were sent to the diversion area for various reasons, including driving with suspended driving privileges, not wearing a safety belt, and suspicion of driving under the influence of alcohol.
