DRIVE ALIVE

The Dayton post partnered with the Miami Valley Hospital (MVH), Good Samaritan Hospital, Children's Medical Center and the Montgomery County Juvenile Court to initiate "Drive Alive." Judge Nick Kuntz and Dr. Peter Ekeh, a trauma surgeon at MVH, spearheaded "Drive Alive," a reality-based program demonstrating true life scenarios and outcomes, aimed at preventing teens from becoming repeat DUI offenders.

The goal of "Drive Alive" is to educate and provide awareness to juveniles about the consequences of driving while impaired. The Juvenile Court acts as the referral source by requiring convicted teens to attend as part of their sentencing for driving under the influence. The program is four weeks long, with sessions held once a week for two hours at MVH. "Drive Alive" is one of several partnerships aimed at making Montgomery County roadways safer. The program coincides with local efforts to increase safety belt usage and minimize drinking and driving incidents during the summer months.
